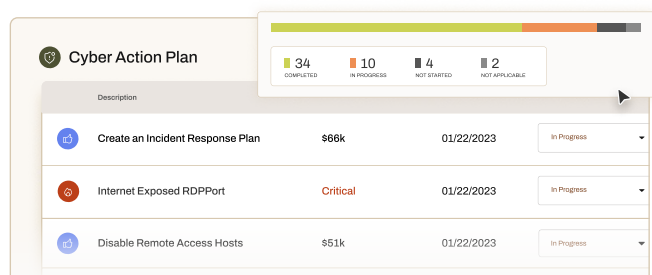

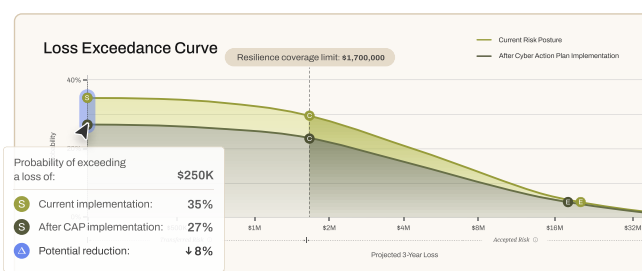

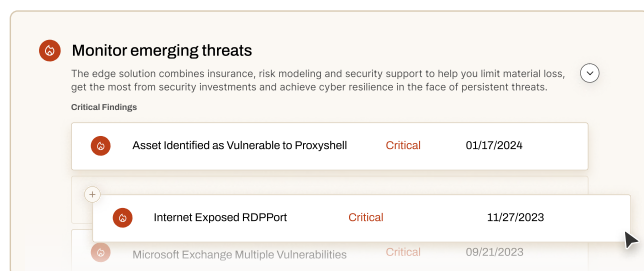
LOSS EXCEEDANCE CURVE
